Our meeting was held February 2, 2010 in Binghamton, New York at the District Office, we used video conferencing to include those not in Binghamton. At this meeting we selected a new deputy chair and discussed future plans for a transition. Justice Molly Fitzgerald has agreed to assume the responsibilities as Chair in the year 2011 with Paula M. Nichols as Deputy Chair. It has been my honor to serve on this committee as Chair for thirteen years and I express my gratitude and admiration for Judge Ellerin, Jill and Fern for their leadership and support. The justice system is better because of their diligent work and input and I was honored to have a small part in this.

Our activities for Domestic Violence Awareness Month are attached. We did not engage in other activities this past year.

The Sixth Judicial District continues to see progress in terms of women on the bench, as judges and Support Magistrates. We are now slightly above the national average.

Our most pressing unmet need in the Sixth Judicial District remains the proper handling of cases involving litigants with mental illness and a great deal of training will be needed to address this issue as resources for outpatient treatment shrink. The Courts are called on more and more to deal with citizens who are marginalized by budget cuts. Our County Court is in the process of developing a Mental Health Court but it will serve Felony Cases only.

In the Sixth Judicial District we have been given a quota of clerk/court assistant slots that must remain unfilled. As more experienced clerks retire, the remaining staff must "pick up the

slack". This creates a tremendous strain on our staff, most of which are women. We need to be allowed to fill our vacant positions.

I submit this final report as the chair of the Committee, I know our future Chair will improve on this committee's function and I wish all the committees, doing this valuable work, the very best.

The following activities took place in the Sixth Judicial District during the month of October, Domestic Violence Awareness Month:

1. Broome County

- a. In October the SOS Shelter celebrated its 30th anniversary of serving the victims of Domestic Violence. The shelter is a non profit organization designed to give immediate emergency temporary assistance to the victims of Domestic Violence. They have interfaced with the YWCA to provide an extended long care solution for the victims of Domestic Violence. The Executive Director of the Office for the Prevention of Domestic Violence spoke at that luncheon, Amy Barish. A copy of the program is attached.
- b. The SOS Shelter, in conjunction with a number of local agencies, both corporate and non profit participated in the "Shine the Light on Domestic Violence" by decorating a tree in front of the Supreme Court. The tree was trimmed with purple lights and bows. Endicott Village Hall was also decorated with purple lights and bows. Both remained decorated throughout the month of October. The Security Mutual Building, one of the tallest buildings in Binghamton, displayed purple lights throughout the month of October.
- c. The SOS Shelter, in conjunction with the local T.V., radio and newspaper media ran several public service announcements regarding services provided by the SOS Shelter and Domestic Violence Awareness Month. A copy of the SOS Shelter newsletter discussing the various events is also attached.

- d. The undersigned, Judge Lehmann was honored with a Certificate of Appreciation from the SOS Shelter on October 2, 2009.
- e. The Binghamton City Domestic Violence Court marked its seventh anniversary of continuous operation.
- f. An MSW trauma class was held at Binghamton University supporting victims of Domestic Violence

2. Cortland County

- a. Cortland City Court wore purple on October 14, 2009 in support of Domestic Violence Awareness Month
- b. The Hon. Julie A. Cambell, Acting Supreme Court Judge, IDV Judge gave a talk about Domestic Violence Court at a meeting of the Zonta Club on October 15, 2009. The Zonta Club is a group of volunteers and business women who contribute their talents and energies to local and international service projects promoting the legal, political, economic and professional status of women.

3. Delaware County

- a. DSS of Delaware County and Delaware Opportunities held a candlelight vigil during the month of October to highlight Domestic Violence Awareness.
- b. A Town and Village Justice training regarding the IDV Courts was held on October 15, 2009. A copy of that agenda and/or training program is attached.

4. Tompkins County

Rebecca Jackson, the Resource Coordinator from the IDV Court in Tompkins County reported the following events during the month of October, 2009

- a. "Sharing stories/healing lives" was a community outreach event at Dewitt Park on October 6, 2009. In that program there were displays and information tables. Speakers also discussed their stories regarding surviving domestic violence incidents and sharing information concerning the resources available.
- b. Displays and information tables were set up at Ithaca College and Tompkins/Cortland Community College providing students with information regarding Domestic Violence and particularly dating violence.
- c. A Domestic Violence bulletin board was unveiled in the Dewitt and Boynton Middle Schools as well as the Boces Community School.

- d. The purple ribbon project with a fact card and information about advocacy services was delivered at Tompkins Community College, Cornell, Ithaca College and thirty other locations in the Ithaca community.
- e. The "Go Purple Day", October 29, set up tents and outreach materials at Ithaca College, Cornell, the local Middle Schools and High Schools.
- f. A number of trainings were presented by the Advocacy Center regarding DV education.
 - 1. Volunteers at Cornell received training in regard to giving assistance and supporting survivors of Domestic Violence or Sexual Assault.
 - 2. Training at the New Hope Center involving an in staff training to improve services to trans-gender victims of Domestic Violence and Sexual Assault, an under-served population.
 - 3. Boces Community School, both the Middle and High School classes received training on healthy and unhealthy relationships, including a discussion on Domestic Violence.
 - 4. The TST Boces GED classes again received training on healthy and unhealthy relationships, including Domestic Violence education.
 - 5. Lansing High School health classes also presented information on healthy and unhealthy relationships, including Domestic Violence information.
 - 6. There was a training at the Dick Van Dyke Addiction Treatment Center for the womens group entitled "Healing from Domestic and Sexual Violence".

The above activities, having taken place in the Sixth Judicial District to promote awareness of Domestic Violence, are respectfully submitted for your review. This district continues to grow in its programs and participants in promoting awareness of Domestic Violence and hopefully working toward the goal of eradicating the same.

Gender fairness committees were created throughout New York State after the 1986 Report of a New York State Task Force on Women in the Courts found that gender bias in the Courts was a "pervasive problem".

The primary mission of the Sixth Judicial District Gender Fairness Committee is to provide a forum for the informal resolution of gender bias complaints from litigants, court employees and members of the bar. The Committee is empowered to receive and review complaints and where necessary to refer complaints to the appropriate forum for resolution. The referrals are monitored to assure that some action is taken. The Committee is limited to accepting complaints involving individuals who are part of the legal system, that is, lawyers and New York Unified Court System Judges and nonjudicial employees.

The Gender Fairness Committee will process oral and written complaints, however, anonymous complaints will not be processed. Complaints may be submitted to any member of the Committee. All complaints received by the Gender Fairness Committee are considered to be confidential. However there may be disclosure to the Administrative Judge and or appropriate reviewing or disciplinary body.

Members of the Gender Fairness Committee also are available to provide information regarding the rights and obligations of attorneys, judges and court personnel. They may also provide training and educational materials as needed.

Activities for Domestic Violence Awareness Month 2009:

On November 4, 2009 we presented a program entitled Cyberstalking-Harassment Lurks in the Digital Age. That seminar was presented at the Monroe County Bar Center, in collaboration with the Monroe County Bar Association and the Greater Rochester Association for Women Attorneys. CLE credits were available.

The presenters at the seminar were Michelle Garcia, Director of the Stalking Resource Center at the National Center for Victims of Crime in Washington, D.C., Gerald Grant, Esq. a Certified Access Data Forensic Examiner with the Federal Public Defenders Office, and Assistant District Attorney Mark Monaghan, Esq. who had worked on a local case involving computer trespass and identity theft.

The program was technical as well as practical, covering topics including how to advise clients when a ongoing crime is pending including the potential for violating orders of protection, how social networking sites, Face Book, My Space, texting, GPS and U tube can be utilized for cyberstalking and abuse, and understanding the intersection of modern technologies with stalking, intimate partner violence and sexual assault. The program was very well attended for a Rochester CLE, with more than thirty participants. The participants gave very positive reviews of the presenters and materials provided.

Activities for Women's History Month 2010:

We did not present a program for Women's History Month 2010. We had planned a program on women in transition in law, law enforcement and politics that had been post-poned from June 2009, because of a visit by the Chief Judge. One of the panelists relocated out of town, however.

Other Activities in the Past Year:

The Gender Fairness Committee, and most particularly I, as Chair, have spent time addressing issues of perceived, if not actual gender fairness issues in the court. Most particularly, several instances of situations, which at the least have created uncomfortable situations for our female court security officers, (in Monroe County they are County Deputies) have been brought to light. I was able to resolve an issue involving uniforms by speaking directly to the Sheriff to have the matter resolved. To address the issues in a more systematic fashion, were are in the process of planning training for all court security supervisors this spring in the areas of gender fairness and sexual harassment.

What are your plans for Next Year?

We plan to have programs next year for both Women's History Month and Domestic Violence Awareness Month. We would also like to continue collaborating with other groups in the community as we did this year with the Monroe County Bar Association and the Greater Rochester Association for Women Attorneys. We also hope to have the sexual harassment and gender fairness training available to a much broader group of employees and supervisory personnel within the Courthouse.

What Issues regarding women and gender in the courts do you think are important this year?

The pressing issues for women and gender in the courts remain constant. There is a continuing concern that women should be treated fairly in promotion and assignments. Our child care facilities have recently been expanded in the Courthouse, but the need continues to outpace the available resources.

Do you see operational issues in your Court or judicial district that adversely affect women or a subgroup of women? Do you see unmet training needs?

We are in the process of meeting the unmet training needs with respect to gender fairness issues in our judicial district. We are working with the Sheriff's Department and Alice Chapman-Minutello to put sexual harassment and gender fairness training sessions in place for Court Security Supervisors, and hope to expand the training throughout the Courthouse.

What kind of help would you like from the NYS Judicial Committee on Women in the Courts?

Jill Laurie Goodman called in the fall, just to have a discussion about issues or potential issues in our district. While she has always been responsive to any request for help, it was really nice to have her reach out. She gave us some good ideas about expanding our contacts within the community. It was also helpful to have the extra meeting this year.

I suggested previously that it would be nice to have the opportunity to attend some of the programs put on by other committees. It would be nice if we all submitted information on our programs in advance to the NYS Judicial Committee on Women in the Courts which could then put out a monthly calendar and make it available to all of the committees. Particularly in Western New York, it is very possible, that individuals in Buffalo, Rochester, Syracuse and surrounding counties might attend each other's programs.



Activities for Domestic Violence Awareness Month 2009:

We co-sponsored a program in conjunction with the Chautauqua County Integrated Domestic Violence Court on Domestic Violence Offender Treatment and/or "Education" Programs. The program included a panel of four speakers from local service programs.

Activities for Women's History Month 2010:

We will be holding a recognition program in Rochester to add the names of recent recipients of our Lamplighters Award to our plaque. The program will be held at the Dolores Denman Courthouse in May or September depending on scheduling.

Other Activities in the Past Year:

Our district wide Lamplighter's Luncheon was held in June honoring women who have made a difference. We had 235 attendees honoring the following women:

We presented a program and photo display at the Wyoming County Courthouse recognizing the contributions of Ella Hawley Crossett. Ms. Crossett, from Warsaw, NY, was president of the New York State Suffrage Association from 1902-1910 and was a leader in securing equal rights for women in our state. The program featured speakers from our committee, from the Wyoming County Court and from the

Wyoming County Historical Society. We had a great turnout from the community and court personnel. A reception and lively discussion followed with some people talking about their connections to and memories of Ms. Crossett's family.

Immediately following the above program, our committee took a guided tour of abolitionist sites in the town of Warsaw and visited the local Historical Society to view abolitionist and suffragette artifacts. We concluded with a picnic in the park.

In October we held a very successful Cancer Awareness Program. The program included representatives from the American Cancer Society, Gilda's Club, Roswell Park Cancer Institute and the Work/Life Assistance Program. The most powerful speaker was the first, a court employee who moved us to tears with his discussion of his discovery and battle with cancer. The program was put on in cooperation with the Erie County Bar Association.

During the months of October and November we sponsored a series of four brown bag programs for court employees, friends and family members on the topic of Caring for your Elderly Parent. Each day's program consisted of 4-5 speakers and included an information table of materials from that day's program and from the previous days programs. The programs were as follows: October 28: Overview of Long Term Care for the Elderly; November 4: Legal Issues; November 12: Services in Erie County for Seniors; and November 18th: Caring for the Caregiver. Members of the Womens Bar were also invited to attend.

Our committee met with our new Administrative Judge Paula Feroleto shortly after her appointment. We are pleased that she has decided to become a member of the committee when she spoke at our October meeting.

We continue to watch the numbers and treatment of 'intimate partners' family offense petitions. At our final meeting of the year we reported on the status of women in judicial and supervisory positions in our courts amongst the district.

Our committee members continue to participate in training new employees on domestic violence and equal treatment. One member presented at the Niagara County IDV Court Stakeholders meeting.

What are your plans for next year:

In January 2010 we sponsored a speaker on long term health insurance to follow up on our Caring for Your Elderly Parent series.

Our March meeting was held at Everywoman Opportunity Center - a local non-for-profit agency whose mission is to help women achieve personal and economic self-sufficiency. It is a great resource for women who come through the courts as it provides many services to women in transition including computer training, a professional clothes closet and a job search library. Their offices are located throughout our district. We met with the director and toured their facilities.

The following programs are being explored, although some may be put off until 2011:

- We are interested in learning more about issues facing Muslim women and children in our courts and in our community and hope to meet with the principal of the Universal School to learn about their programs and to tour the school.
- We're currently organizing a Human Trafficking Program to be held in Niagara County.
- We'll be traveling to Rochester for a reception adding the names of recently honored Lamplighters to our plaque in the Dolores Denman Courthouse.
- We plan on participating in the opening of the new child care center at Buffalo City Court.
- We're exploring a program on stress management for court employees.
- For Cancer Awareness Month in the fall we plan a tour of Gilda's Club for court employees.
- For Domestic Violence Month, we're exploring a program on cyber-bullying, sexting and texting.
- We talked about a program on basic self-defense for court employees.
- We plan on inviting the new head of the Family Justice Center to speak on her vision for the future of the center.
- We would like to cooperate with the promotion of Hispanic Heritage Month. We also plan to include the Womens Bar Association in spreading the word on our programming.
- We have talked about expanding our Caring for Your Elderly Parent Program into one of the smaller counties in our district.

What issues regarding women and gender in the courts do you think are important this year?

Again this year, accessibility to services is a real issue.

We need more supervised and therapeutic-supervised visitation programs set up for non-custodial parents and we need them to be more accessible during weekends and non-working hours. So, too, do we need more monitored exchange programs so that children don't have to be exchanged at police stations.

We need more available mediation and treatment programs.

Important also is the threat of cutbacks in civil legal services which would negatively impact women going through divorce, needing domestic violence advocacy or needing representation to avoid eviction from their homes.

Another concern is not unique to the courts, but is a universal problem facing women in the work force: responsibility for caring for our aging parents. As more and more women have entered the workplace, there are fewer persons left at home to care for our parents. According to statistics, these are mostly our mothers. This is placing a greater stress on our co-employees and on a growing number of attorneys - mostly women - who find themselves trying to balance home, employment and the care for a beloved parent.

We also need to make our courtrooms more friendly to the elderly - increased hearing enhancement equipment and handicapped accessible courtrooms. This need, however, is not limited to women litigants.

Do you see operational issues in your court or judicial district that adversely affect women or a subgroup of women? Do you see unmet training needs?

Both our Administrative Judge and our District Executive are active committee members. Members of our committee are actively involved in decision-making and training of court employees. Our district tends to be proactive in meeting training needs.

Also on the plus side, in Family Court, we have recently seen the increased use of videoconferencing and telephonic interpreting service as well as the introduction of enhanced speaker phones for the judges. They have proven very helpful in increasing accessibility to the courts and freeing up time and resources.

What kind of help would you like from the NYS Judicial Committee on women in the Courts?

I hope the State Committee will continue to offer the program for local committees outside NYC.

The annual meeting of all chairs is very beneficial in brainstorming new ideas for programming. I find the Annual Reports an especially useful reference material.


Ella Hawley Crossett was a recognized regional and national leader of the women's suffrage movement. Born in 1853, Ms. Crossett, a resident of the Town of Warsaw, New York, worked tirelessly to promote women's right to vote and to participate in our democratic process. In 1891, she organized a women's suffrage convention in Warsaw, at which Susan B. Anthony spoke. In 1902 she was elected President of the New York State Suffrage Association, a position she held for eight years.

Ms. Crossett's activities were not limited to fighting for the vote for women. Under her leadership, she was instrumental in seeing that women held positions on the local school board. She also organized the Warsaw Chapter of the Red Cross during World War I. Ms. Crossett died in 1925. The Ella Hawley Crossett Memorial Nurses' Home of the Wyoming County Community Hospital was dedicated in her memory.

Judge Bailey said, "The Gender and Racial Fairness Committee is pleased to sponsor this event recognizing the contributions of a great American woman whose work resulted in the recognition of a bedrock constitutional principle that we all now take for granted – every citizen's fundamental right to vote."

Judge Feroleto said, "Ms. Crossett's tireless efforts remind us of the important role the courts play in preserving democracy and liberty for all under the law."

Do you see operational issues in your court or judicial district that adversely affect women or a subgroup of women? Do you see unmet training needs?




In furtherance of that

Members: See attached. We are composed of judges, lawyers, victim advocates, educators, Bar association presidents, court employees and members of various county agencies working with women and children.

Dates of meetings: Our lunchtime meeting is held monthly with the exception of July and August. Meetings usually feature a guest speaker. This year, we had the supervising probation officer for the specialized women's unit, the supervising language interpreter for all Suffolk courts, attorneys from Nassau Suffolk law services, among others.

Average attendance: We average 15 - 20 members per meeting. The live meeting is held in Central Islip with a video conference feed to Riverhead.

Activities for Domestic Violence Awareness Month 2009: We presented a CLE seminar in conjunction with the Center for Court Innovation on The Intersection of Domestic Violence and Substance Abuse and Women's Use of Violence in Intimate Partner Relationships (see attached flier). Two hours of CLE credit was available. Ninety five persons attended including judges, prosecutors, defense attorneys, matrimonial practitioners, law guardians and court attorneys.

Activities for Women's History Month 2010: We plan to celebrate the accomplishments of the committee by sponsoring an info expo "Access to Justice." This will feature representatives from the many agencies and organizations available to assist all those who use our courts.

Other Activities in the Past Year:

October: Breast Cancer Awareness. We distributed information at both courthouses from the American Cancer Society.

November: We contributed food and gift card for the Thanksgiving baskets distributed by the Chidren's Center.

December: We donated money and helped with preparation of the holiday "Adopt a Family" gift baskets distributed by the Children's center.

January: We collected hats and gloves at our holiday luncheon for distribution by the Children's Center. One of our members also knit scarves.

February: Our Heart Health event brought nurses from Stony Brook Hospital to both court houses to take blood pressure and distribute literature from the American Heart Association. Several people were advised to seek medical attention. At least one was directed to the nearest emergency room

Members attended the Bagels and Books breakfast for the Children's Center, donating new books to be given to each child using the center.

We look forward to our annual Breast Health Awareness program and another CLE accredited Domestic Violence program. We would like to do more than one Heart Health program since this event is particularly well-received and seems to actually save at least one life each year. We are building an archive of materials documenting the history and contributions of women in the courts of Suffolk County.

What issues regarding women and gender in the courts do you think are important this year? The overall economic conditions in Suffolk County have increased concerns regarding domestic violence, housing, evictions, foreclosures, divorce, separation and support. These issues seem to disproportionately involve women.

Do you see operational issues in your court or judicial district that adversely affect women or a subgroup of women? Do you see unmet training needs?

Due to the overall economic conditions and cuts in funding, a number of agencies providing legal services, particularly in situations involving domestic violence, have been discontinued. This makes training for 18b and pro bono attorneys that much more important. Additional training for pro bono attorneys in the areas listed above would also be helpful.

What kinds of help would you like from the NYS Judicial Committee on Women in the Courts? We look forward to attending the state meeting on April 20 in New York City. This will give us the opportunity to network with representatives from other counties and share information and solutions to problems we share, and those we have yet to identify. This is the best help the state committee can give us: information.

The film profiles the iconic journalist Helen Thomas, a tour de force in political reporting, who has covered the White House and every president since John F. Kennedy. Our speaker was Irene Cornell, journalist with WCBS Radio. In January we presented In The Family, which is a poignant account of one young woman's striving to live fully in the shadow of the cancers that afflict women's lives. We are also looking forward to presenting: The Greatest Silence: Rape In The Congo and the Emmy Award winning film for best documentary entitled A Walk To Beautiful (which also takes place in Africa and presents a devastating childbirth injury called obstetric fistula). As always each film presentation is lead by a moderator and in some cases includes a guest speaker, followed by audience discussion.

What are your plans for next year?

Our tentative plans for next year include: The Women's History Month Program, Domestic Violence Program, Food and Clothing Drives, Gender Fairness on Film Series, Meet the Author, a fashion show for those women trying to get back into the workforce, CLE programs and a special series of programs on gangs and violence in cooperation with the Bronx Borough President's Office and Commissioner Galen D. Kirkland, of the State Human Rights Commission.

What issues regarding women and gender in the courts do you think are important this year? As we have stated in the past the following issues regarding gender in the courts still hold extreme importance and relevance. Especially during an economic downturn, women as their families primary caregivers bear most of the burden and tremendous stress. There appears to be an increase in crime against women due to more unemployment and possible increase in domestic abuse and stalking of women by unemployed men. We have still found that there is a "glass ceiling" with women in various court positions. It has also been previously noted that there is a need for childcare facilities in all Bronx Courts for litigants as exists in Family Court.

Do you see operational issues in your court or judicial district that adversely affect women or a subgroup of women? Do you see unmet training needs?

As we have stated in the past, it had been brought to our attention by one of our attorney committee members that there might be a discriminatory issue relating to pretrial release recommendations relating to women defendants. It was noted that stay-at-home female caretakers were not being given credit as women who work and women who were in school. We contacted and met with the Criminal Justice Agency in order to encourage them to update that portion of their standard form. Discussion is still continuing.

Justice Price has brought this issue to the attention of the Judges on the Criminal Side. We are pleased to report that they are now more sensitive to this issue.

What kind of help would you like from the NYS Judicial Committee on Women in the Courts? As we have stated in the past the NYS Judicial Committee on Women in the Courts provides ideas and program suggestions for our review and implementation. As in past years we have an urgent need for monetary contributions in order to continue putting on our programs and present additional innovative programs. However, the decrease in funding of our programs by OCA is having a serious deleterious effect on these events.



SUSAN CHINITZ, PSY. D. DIRECTOR, EARLY CHILDHOOD CENTER ALBERT EINSTEIN COLLEGE OF MEDICINE

Susan Chinitz is a psychologist with specialties in the areas of infant mental health and developmental disabilities in infancy and early childhood. She is the Director of the Early Childhood Center and the Center for Babies, Toddlers and Families, both therapeutic programs for infants, toddlers and preschool age children at the Children's Evaluation and Rehabilitation Center. Dr. Chinitz is an Associate Professor of Clinical Pediatrics, and the Charles S. and Patricia T. Raizen Distinguished Scholar in Pediatrics at the Albert Einstein College of Medicine. She is also on the faculty of the Parent-Infant Psychotherapy Program at the Columbia University Center for Psychoanalytic Training and Research.

Dr. Chinitz is on the Board of Directors of the New York Zero-to-Three Network, an organization that provides professional development and collaboration support for researchers and clinicians from multiple disciplines and service sectors that interface with infants, toddlers and their families. She is also on the editorial board of the Journal for Early Childhood and Infant Psychology.

Dr. Chinitz has obtained city, state and federal grants to provide developmental and infant mental health services in community-based programs for young children, including the first allocation of city funding specifically for infant and early childhood mental health

services that currently supports infant mental health services in primary pediatric care, preschools, foster care agencies and the Family Courts. She received a grant from the Administration on Children and Families to create the first Early Head Start Program in the Bronx; and one from the New York State Developmental Disabilities Planning Council to create a childcare and preschool program that provided developmental therapies and behavioral supports for children with disabilities and training for childcare staff, and grants from private foundations to start a court-affiliated infant parent intervention program.

Dr. Chinitz is an invited speaker at professional conferences and has authored chapters and journal articles related to psychological assessment of children with disabilities, social-emotional development in infancy and early childhood, young children with attachment disorders and developmental disabilities, young children in the foster care system, and trauma in infancy and early childhood.

Carmen Beauchamp Ciparick, *Associate Judge of the Court of Appeals*, was born in New York City, grew up in Washington Heights, graduated from Hunter College in 1963 and received her J.D. from St. John's University School of Law in 1967. She served as a staff attorney with the Legal Aid Society in New York City from 1967 to 1969 when she became an Assistant Counsel for the Judicial Conference of the State of New York; in 1972, Chief Law Assistant of the Criminal Court of the City of New York; and in 1974, Counsel in the Office of the New York City Administrative Judge. In 1978, she was appointed Judge of the Criminal Court of the City of New York, and in 1982 was elected to the New York State Supreme Court. She was appointed to the Court of Appeals on December 1, 1993 by Governor Mario M. Cuomo and sworn in on January 4, 1994, the first Hispanic to serve on the Court of Appeals. 

In 1989, in accordance with an Office of Court Administrative directive that Administrative Judges establish Gender Fairness Committees within their respective courts, our Supreme Court, County Clerk's Office and Appellate Term, established an Anti-Bias Committee to promote gender fairness, tolerance, equal opportunity and cultural diversity. During the past 20 years, our New York County Anti-Bias Committee has been among the most active such committees in the State. In 2007, the Hon. Jacqueline W. Silbermann, Administrative Judge (ret.), reorganized our Anti-Bias Committee, effective January 1, 2008 by appointing two successor Committees: the Gender Fairness Committee and the Cultural Diversity Committee. We continue on under the guidance of our current Administrative Judge, the Hon. Sherry Klein Heitler.

The Gender Fairness Committee has three sub-committees devoted respectively to sponsoring programs for Women's History Month (March); Take Our Children To Work Day (April); and Domestic Violence Awareness Month (October). Of course, our Gender Fairness Committee does not function in a vacuum and many activities in our court by our sister Cultural Diversity Committee, by other court committees, and by individuals, complement significantly the work of our Gender Fairness Committee.

A word about our June "Annual Unity In Diversity Program", now sponsored by our Cultural Diversity Committee. This wonderful program held in our Rotunda is a social event featuring the cuisine of so many of the diverse cultures within the court system and beyond. Last year, approximately 40 Bar Associations and cultural associations participated and literally hundreds of Judges, court staff, practitioners and other "constituents" of our court enjoyed this mid-day program. Other activities of our court which complement and support the goals of our Gender Fairness Committee, include our Court Tour Program, the largest such program in the court system hosting as it does thousands of students each year together with Judges and dignitaries from all over the world (Ms. Yasmin Beydoun, Director); our large Summer Intern Program (with its own lecture series) which last summer, as in previous summers, attracted more than 100 law students, a clear majority of whom were women law students; our Newsletter, *Just Us*; and various cultural, ethnic and educational programs, sponsored by a variety of court committees and Bar groups.

Ms. Ferrato, who's work has been featured in such publications as Life Magazine and the New York Times is the author of "Living with the Enemy", a best selling book since its release in 1991, which chronicles family relationships plagued by intimate violence. Ms. Ferrato presented a photo display, media presentation and offered remarks to over one hundred people at our meeting. After the speaker concluded her remarks we had an open question and answer session.

Activities for Women's History Month March 2010:

On March 19, 2010, our Committee presented a program featuring renowned professor and ethics expert Paula Franzese. We also honored Elizabeth "Betty" Piervencenti from the County Clerk's Office for years of outstanding service to the Court and legal community since 1961.

What are your committee's biggest strengths?

Our Committee's greatest strength is the intelligence, high energy and commitment of its members, as well as the support of our local administration, all of which are reflected in the outstanding programs which have been sponsored by the Committee and its affiliated committees, groups and individuals.

What are your committee's biggest impediments?

Our court is among the busiest in the State. Thus, there is always a great deal of competition for resources and attention. It is in this very competitive environment that we seek to have our message heard. We also face logistical problems with courtrooms and back offices located in four separate court buildings, 60, 80 and 111 Centre Street as well as 71 Thomas Street in downtown Manhattan.



4. DATES OF MEETINGS (Full Committee).

April 23, 2009, September 29, 2008, October 16, 2009, February 8, 2010, February 24, 2010, March 10, 2010.

Much of the work of the Gender Fairness Committee is performed through subcommittees. For example, the Bring Your Child to Work, Family Feud Games, Conference on Women as Leaders and Book Drive subcommittees.

5. AVERAGE ATTENDANCE. 15 to 6

6. ACTIVITIES FOR DOMESTIC VIOLENCE AWARENESS MONTH - 2009.

a. Discussion on the Impact of Domestic Violence in the Asian, Arab-American, Orthodox Jewish and disabled communities of Brooklyn. On October 29, 2009, in conjunction with the Kings County Family Court Gender Fairness Committee, a panel discussion was held during lunchtime in the ceremonial courtroom at 320 Jay Street (flyer annexed). Panelists included Yi Hu Chang, Assistant Director of the New York Asian Women's Center, Kinaja Janardhanan, Director of the Arab-American Family Support Center, Chana Widawski, organizer of Project Kol Tzedek for the Kings County District Attorney's Office, and Georgette Delinois, Director of Barrier Free Living. Wanda Lucibello, Chief of the Kings County District Attorney's Domestic Violence Bureau was moderator of the discussion.

Approximately **50** people attended. Light refreshments were served. Event organizers included Judge Sarah Krauss, Izetta Johnson, Lesley Friedland, Yvonne Marin, Judge Rachel Adams and Justice Fern Fisher.

b. <u>Book Drive</u>. The Committee, for the **third** year, collected books for families residing in Domestic Violence Centers. More than **300** books for children and adults were donated by court personnel, with the expectation that shelter residents will take the books with them when they leave and begin home libraries. The book drive was lead by committee member Loretta Argiro of the County Clerks Office. [letter from Center Against Domestic Violence, annexed]. The Book Drive was conducted during December 2009.

7. ACTIVITIES FOR WOMEN'S HISTORY MONTH – 2010.

- a. <u>Essay Contest</u>. For the past four years the Committee has presented a \$250 scholarship to a high school essayist during our Women's History Month program. Attempts to engage students at the Urban Assembly School for Law and Justice (housed in the former Family Court building) in the essay contest were unsuccessful. The contest was then opened to the children of Supreme Court employees (notice annexed). In keeping with the National Women's History Project's theme for 2010, the topic is "Writing Women Back Into History." The scholarship will be presented to the award-winning essayist at the Ruth E. Moskowitz Lecture on March 22, 2010.
- b. <u>Court Feud Challenge Games March 18, 2010</u>. In order to encourage broader participation by court personnel in Women's History Month activities, the Committee has hosted a series of women's history court-feud/trivia games, during March, for the past **four** years. Teams of five compete against each other during the lunch hour. The games foster collegiality while increasing an awareness of the role of women in history and in society today. To date, four

teams have been organized: Family Court, County Clerks, Civil Court and Administration for Children Services (flyer annexed).

This year the Committee **outreached** to agencies and court personnel from the various courts in downtown Brooklyn. Judge Robyn Sheares, Loretta Argiro, Leah Richardson, Lesley Friedland, Major Luz Bryan and Izetta Johnson are members of this subcommittee. Judge Sheares and Justice Albert Tomei have agreed to MC the games.

c. <u>Ruth E. Moskowitz Lecture — March 22, 2010</u>. In collaboration with the Brooklyn Women's Bar Association, the Family Court Gender Fairness Committee and the Civil Court Gender Fairness Committee, the Committee will hold its annual Women's History Month event in the Surrogates Court on March 22, 2010 at 5:30 P.M. (flyer annexed).

The Honorable Nancy T. Sunshine, Kings County Clerk and Commissioner of Jurors, will be our guest lecturer. A scholarship will be awarded to the winning student essayist, and a light reception will follow.

Judge Rachel Adams, Justice Gloria Dabiri, Pamela Elisofon, Esq. and Hemalee Patel, Esq. are organizers of this event.

d. <u>Women in History Quotations</u>. Quotations by noted women were posted by the IT Department on the employee space bulletin board throughout March.

8. OTHER ACTIVITIES IN THE PAST YEAR.

a. Bring Your Child to Work Day — April 22, 2010.

On National Bring Your Child to Work Day the Criminal and Civil Terms will participate in this annual event which is open to children, ages 7 to 14, of court employees. Group activities will be held between 8:30 A.M. until 4:00 P.M. A draft of the program schedule is annexed.

This year "The Concept," a play about drugs and making bad choices will be presented.

It is anticipated that, as in past years, the New York State Court Clerks Association, the New York State Supreme Court Officers Association, the Equal Employment Opportunity Office, the Tribune Society, the Shomrim Zdzek Society, Cervantes, Amicus Curiae, and the Association of Secretaries to Supreme Court Justices will partner with the Gender Fairness Committee. Justice Karen Rothenberg is chair of this subcommittee. Izetta Johnson will co-ordinate activities at 320 Jay Street and Yvonne Marin, Esq. at 360 Adams Street.

b. Women in Leadership Focus Groups — October 16, 2009 and October 30, 2009.

The Committee held two informal lunchtime focus groups to explore some of the challenges women face as judges, supervisors and managers, and to obtain suggestions on the kind of training, tools and skills-building that would be most helpful to participants. The first session was attended by some 15 female management level staff and judges from the Kings Supreme Court, Civil and Criminal Terms. A similar number of women judges attended the second session.

The sentiment expressed by many participants was that while women have made progress, particularly within the court system, there are still challenges for women in attaining leadership positions, and as a result of the perception and expectations people have of female leaders.



The Center and the women we serve are grateful for all you and the Gender Equity Committee of the Court have done over the years. Your last donation of books provided holiday gifts for the women and children in all three of our shelters, for the families involved with our community based support groups and for peer leaders at the seventeen schools we serve. The previously owned books went into the shelter libraries and the three day care and after school programs the Center operates for children from violent homes.

I know that you agree that prevention is the best service we can offer to end relationship abuse and domestic violence. The Gender Equity Committee's last donation and their previous book drive and Halloween Costume drive have not only benefited the victims of relationship abuse, but have helped prevent it in the future.





The Concept was first conceived in 1968, by Lawrence Sacharow. He perceived the connection between the methods evolved at Daytop to meet the needs of its residents and the ritualized theater he had been studying in his travels. He worked the experiences of the recovering addicts into a coherent theater piece featuring those individuals as "themselves." Director Lawrence Sacharow's work has earned a place in theatrical history as the avant—garde pioneer of Open Theater.

The internationally acclaimed, original Concept opened at Café La Mama and ran for three years Off Broadway, then toured the U.S. and Europe performing at the Moscow Art Theatre in St. Petersburg, the United Nations and gave a command performance at the White House. In 1987, The Concept was "reinvented" by a new generation of Daytop clients and opened at the River Arts Repertory in Woodstock, New York, where Sacharow was the artistic director. It later performed at New York's Circle in the Square. The Concept continues to perform and bring its message of hope and the human capacity to grow and change to school audiences, community organizations and Performing Arts Theaters.

What are your plans for next year?

The Queens Criminal Court Gender Fairness Committee, previously a subcommittee of the Citywide Gender Fairness Committee, has now been merged with the Supreme Court, Criminal Term, Gender Fairness Committee (now called Criminal Court Matters Gender Fairness Committee). It is co-chaired by Hon. Marcia Hirsch, Supreme Court Justice, Criminal Term, and Hon. Toko Serita, Criminal Court Judge. We will be having our first meeting as the new committee on April 28th, 2010. Previous to this, during a restructuring phase, Judge Serita and Justice Marguerite Grays were co-chairs of a committee that represented both the criminal and civil side, supreme and criminal court. In that capacity, we successfully put on several programs, including a very well attended lecture in recognition of Domestic Violence Awareness Month in October 2009 with Richmond County DA, Hon. Daniel Donovan. For that event, CLE credit was provided and we had over 65 attendees.

We anticipate organizing activities around Domestic Violence Awareness Month and Women's History Month, at the very least, in addition to other activities throughout the year. We also thought it might be a good idea to propose an annual joint event with the other gender fairness committees in this county.

Based on the 2010 restructuring of the committees, however, we are in the process of assessing the continued viability of a Citywide Criminal Court Gender Fairness Committee, which has proven highly successful and rewarding for the membership, the courts, and the communities at large. (Attached is the 2008-2009 Summary for the Citywide Gender Fairness Committee, Criminal Court of the City of New York, that outlines the work and the mission statement of this collective venture of the former "subcommittees," now independent committees.)

What issues regarding women and gender in the courts do you think are important this year?

One of the proposed activities for the committee this year, as part of a continuation of our joint citywide effort from 2009, is to have a workshop around transgender issues in the court system. Both the Manhattan and Brooklyn Criminal Court subcommittees presented these workshops last year, and Queens is now the last

one to do so. This is a very relevant topic given the increased number of transgendered defendants in the prostitution diversion court in Queens County, as one example, and the treatment of the transgendered population by the criminal justice system.

Another area of concern during this or any other year are the issues of underage prostitution and human trafficking. Although there are a handful of criminal courts within the state that have taken a different approach to the way that underage defendants charged with prostitution related offenses are dealt with, viewing them as victims in need of help rather than as criminals, this is the exception rather than the norm. Judge Serita presides over the prostitution diversion court in Queens County, and its success in helping defendants 21 years and younger illustrates the need for such diversion courts around the state. Additionally, we have only recently started to address the scope of the issues involving trafficking victims, whether they be domestic or international, labor or sex trafficking victims.

Do you see operational issues in your court or judicial district that adversely affect women or a subgroup of women? Do you see unmet training needs?

Not at this time.

What kind of help would you like from the NYS Judicial Committee on Women in the Courts?

I would like to see the Comm take a more active role in helping to facilitate resourcesharing, as well as increasing communication amongst the gender fairness committees state-wide. It could also be helpful in terms of information gathering and research around a variety of issues.



Activities of the Citywide Comm 2008 - 2009

The Citywide GFC has made significant strides in the past year and has succeeded in accomplishing its objectives for the year. During the first year of its existence as a *citywide* committee, the emphasis was on developing and strengthening each of the local subcommittees so that it could function independently, though with the recognition that it was part of a larger entity (<u>see</u> last year's Annual Report). Thereafter, late last year, the citywide GFC agreed upon a joint effort focusing on the issue of teen dating violence in recognition of Domestic Violence Awareness Month in October & November of 2008. This effort was spearheaded by Judge Tanya Kennedy who, at the time, was in Manhattan Criminal Court. The project entailed each county sponsoring two separate events on this topic, with some subcommittees partnering with local high schools by either inviting them to a program in the courthouse or by visiting their schools in conjunction with other organizations involved in this work. Doing this project helped realize several of our goals as a committee, including the following:

- Becoming more unified as a committee by working on common issues. This was the first time that each of the subcommittees engaged in a joint project together and it illustrated the success of our model by allowing us to serve the needs of our respective communities while engaging in a joint cross-county collaboration that enabled us to work toward common themes for Domestic Violence Awareness Month. We created a steering committee responsible for overseeing our six separate presentations for DV Awareness Month.
- ♦ Developing relationships with our communities. Our citywide project for DV Awareness Month also exemplified our commitment to developing ties between criminal court and the various communities it serves as well as bringing the work of other organizations to different audiences in the courthouse (or to other locations). For example, the citywide GFC reached out to two different high schools as part of this project, Murray Bergtraum High School in Manhattan, and Pacific High School in Brooklyn, so that we could expose students to criminal court as well as to issues surrounding teen dating violence, and by so doing,

provide a service to the community. We also co-sponsored these events with the New York Women's Bar Association and the Queens County Women's Bar Association. Additionally, we invited several organizations to do these presentations for court-staff, attorneys, service providers and students, such as the NYC Mayor's Office to Combat DV, the NYC Healthy Relationship Training Academy, Day One, and Men Can Stop Rape Now. We feel that this citywide project embodies many of our concerns with respect to forging ties with our various communities, raising awareness around issues concerning gender discrimination, and providing a forum to enhance gender equality in the court system.

Other notable developments

- Our collective identity as a citywide committee has been strengthened by our ability to use technological resources such as videoconferencing capability to meet regularly. Thus, in addition to our local committee meetings, we have had 7 citywide videoconferencing meetings throughout the past year in which all members were invited to attend. We have also had two "Meet & Greet" functions within the past year, bringing together members from all three counties for an opportunity to meet and get to know one another better (this was the first time that some members from other counties met each other off screen).
- ♦ Mission Statement. It was strongly felt by members of the citywide GFC that a mission statement was important to solidify our identity and to provide coherence for our local and collective work. A mission statement subcommittee was formed, chaired by Judge Rita Mella and the following mission statement was recently approved by the entire comm. It states the following:

The New York City Criminal Court Gender Fairness committee seeks to promote the ideal of gender equality. Our mission is to consider, raise awareness and address issues which relate to gender and which have a bearing on work, wellness, justice, and human dignity. The committee believes in the strong and equal participation of everyone, without regard to gender, in all sectors of the Criminal Court.

What are your plans for next year?

With 3 new vice chairs, spread out in differing areas of the district, we will hopefully form a coherent plan address issues affecting women in our district. There are already many worthwhile programs addressing domestic violence awareness. We can work with those and concentrate on issues directly relating to women in our courts.

What issues regarding women and gender in the courts do you think are important this year?

Women litigants continue to be underserved in our courts, due to low incomes and childcare responsibilities which prevent them from adequate access to the courthouse and to legal representation. There is a great need for attorneys to represent indigent women on matters for which assigned counsel is not available. There is a need for childcare services for women litigants who have to bring their children to court with them.

Do you see operational issues in your court or judicial district that adversely affect women or a subgroup of women? Do you see unmet training needs?

There needs to be greater incentive for attorneys to accept pro bono cases. The court system should be able to provide incentives to encourage this, perhaps through more CLE credits, waiver of attorney registration fees or free bar association memberships for those who provide pro bono services.

What kind of help would you like from the NYS Judicial Committee on Women in the Courts?

The addition of 3 vice chairs will be a great asset. Perhaps working with other nearby districts, such as the 3rd (Albany area) district, we can combine forces and develop some good programs and new ideas. Another statewide meeting upstate, as took place several years ago, would be of interest to us.

Activities: The New York County Criminal Court Gender Fairness Committee continued to operate this year as part of, and in conjunction with, the citywide Gender Fairness Committee of the Criminal Court, chaired by Judge Toko Serita. During this year, the committee organized and co-sponsored events on various issues that relate to gender equality with the objective of raising awareness among court staff and court users. At least one of these events was coordinated as part of a city-wide effort of the Criminal Court Gender Fairness Committee.

Events

The committee organized or co-sponsored the following events since our last report:

1) Law Day Program

On Friday, May 1st, the New York County Gender Fairness Committee ("GFC") of NYC Criminal Court held a Law Day program for students of the Murry Bergtraum High School. The school's Assistant Principal and 17 students, 16 of which were women, attended the program.

The students participated in a discussion on the Writ of Habeas Corpus, which was the topic of the program, and the case *Ex parte Merryman*, which documents President Lincoln's suspension of the Writ of Habeas Corpus during the Civil War. A member of our committee led the discussion. The topic of Habeas Corpus and a discussion of this particular case were suggested by the American Bar Association as topics for Law Day programs for High School students across the country. The moderator then explained how the Writ of Habeas Corpus can be seen in present time with enemy combatants held in Guantanamo Bay, and on a daily basis in arraignments. The students were then able to observe what happens in the arraignment process.

The day also included a number of activities in which the students had the opportunity to interact with judges, court administrators, and representatives of the New York City Department

of Corrections and the Police Department. The presentations were informative and the students were full of questions. After the presentations, the students were taken to the empty correctional pens behind the arraignment courtrooms. They were amazed by what they saw and smelled.

The event concluded with the students having lunch with the Judges of New York City Criminal Court. The students enjoyed speaking to the judges about how they became judges and the judges gave the students valuable guidance about the students' future endeavors and how to achieve them.

Last fall, students from this high school participated in the Teen Dating Violence program held in the courthouse as part of the activities organized by our committee in recognition of Domestic Violence Month. We had established a relationship with the school then, and nurturing that relationship was important to us. Our committee is interested in continuing to build connections with community groups and organizations, and in opening the doors of the courthouse to members of the public. This Law Day program constituted one more step in that direction.

2) Domestic Violence Awareness Month

On Thursday, October 8, 2009, the New York County Gender Fairness Committee held a Domestic Violence program in recognition of Domestic Violence Awareness Month. The program was entitled "The Faces of Domestic Violence." During the program, two short documentary films were shown. The DVD with both documentaries, was provided by the Court Officer's academy. Everyone was encouraged to bring their lunch.

The first documentary was called "The Faces of Domestic Violence." The film was 19 minutes long and discussed the problems that arise in domestic violence cases, including the effects of domestic violence on the victims and the family. The film also discussed the importance of looking for and providing help to victims of domestic violence.

The second film was called "Female Batterers." This 9-minute film, produced by the TV show 20/20, discussed domestic violence where the women were the batterers.

Approximately 20 people participated in the program. After showing the films, the floor was opened for discussion. A lively discussion took place especially around issues raised by the second film. The fact that the vast majority of batterers are men, and that women tend to engage in violent behaviors in self-defense were stressed during the discussion.

3) Program on Transgender Issues

On December 8, 2009, from 5:30 p.m. to 7:15 p.m., the Gender Fairness Committees of the New York County Supreme and Criminal Courts, in conjunction with the Lesbian, Gay, Bisexual & Transgender Law Association of Greater New York (LeGaL) and The Alliance - The

Gay-Straight Alliance of New York State Justice System, held a program titled *Transgender Issues in the Criminal Justice System* in room 1517 of the New York County Supreme Court.

This event, attended by more than sixty individuals, featured an engaging and comprehensive presentation by Gabriel Arkles, Esq. and Elana Redfield, Esq., both staff attorneys with the Sylvia Rivera Law Project that work with clients who are incarcerated and/or have been involved with the criminal justice system. The presenters provided the attendees with a basic vocabulary for discussing gender identity, including screening a video titled *Transgender Basics*. From this foundation, the presenters discussed the discrimination and general lack of awareness and sensitivity experienced by their clients and members of the transgender community in their dealings with the criminal justice system, including in prison and alternative-to-detention programs. The presenters concluded by providing advocacy tips for working with transgender clients as well as suggestions/considerations for courthouse protocol. A lively question and discussion session ended the presentation.

The program was a great success. Following the formal conclusion of the program, a significant portion of attendees joined the committee members and presenters in refreshments and further conversation. More than thirty of the attendees earned CLE credits and many attendees requested additional information about the Gender Fairness Committees, including several requests to be included on email lists for future events.

4) International Women's Month

On March 9, 2010, our committee co-sponsored a program entitled "Courting Justice" in celebration of International Women's Month. The program was organized by the International Association of Women Judges as well as the National Association of Women Judges, New York Chapter, and was held at the United States Court of International Trade in Manhattan. The program was co-sponsored by a number of organizations, including several of the Gender Fairness Committees of the courts.

The program featured the screening of a documentary film by the name of "Courting Justice" about the challenges faced by six women judges in South Africa during the transition from apartheid to democracy.

The program was very well attended and received. More than a dozen women judges from other countries were in attendance. Also present was the United States embassador to the U.N. Commission on the Status of Women, Meryl Frank, who spoke about the United States' efforts to build consensus among the U.N. Commission delegates on strategies for promoting gender equality around the world.

Wellness Program

Exercise Class - Our committee continued this year to sponsor lunch-time exercise classes for court employees. The classes started in August 2008. The instructor is also a court employee and the classes take place in one of the courthouses.

The Court's Specialized Parts

The New York County Criminal Court continues to have a specialized part for Domestic Violence cases. A resource coordinator, who is a full-time court clerk, coordinates the referral and follow up of defendants to treatment programs that are part of the court's mandate in the disposition in these cases, such as anger management programs and programs for batterers. The coordinator also provides information to the court regarding the availability of alternative sentencing programs in appropriate cases. The specialized domestic violence part continues to work jointly with the New York County Integrated Domestic Violence Court (IDV-C) in the Supreme Court, and cases are transferred to the IDV-C court when the families are involved in simultaneous proceedings in more than one court.

The Midtown Community Court continues to handle roughly 80% of the prostitution cases in New York County. The vast majority of the defendants in these cases receive alternative-to-jail sentences that involve the provision of services designed to guide the participant out of the prostitution lifestyle. Of those that receive social service sentences, more than 80% percent comply with their court's mandate.
