SALUTE TO NEW YORK'S MENTORING PROGRAMS

"There's a face of a child at the end of everything we do," said Greg Owens, Director of Special Projects for NYS Office of Children and Family Services, at a statewide conference celebrating national Mentoring Month. The conference, presented by NYS OCFS with the Mentoring Partnerships of the Capital Region, Long Island, New York City, and Onondaga County, provided information on the partnerships around the state and honored a number of exceptional mentors.

Speakers included Greg Owens; NYS OCFS Acting Commissioner Gladys Carrion; Jean Cohen, Executive Director of the Mentoring Partnership of Long Island, who presented at last fall's CASA Directors' Meeting; and keynoter Dr. Susan Weinberger, national mentoring expert, educator, author and parent. Weinberger, or "Dr. Mentor" as she is known, credited CASA in her speech as one of the primary advocacy movements on behalf of children in the state.

We discussed the potential for collaborations between CASA and mentoring programs in the areas of training, recruitment, fundraising and program development. Cohen said that mentors sometimes struggle when their mentees become involved in court proceedings, and also offered mentoring programs as an option for children identified by CASA as needing additional resources.

January 25th is "Thank Your Mentor Day". This is an opportunity to identify someone in your life who formally or informally mentored you. For more information, go to www.WhoMentoredYou.org . As one honoree stated, "Children don't spell love L-O-V-E. They spell it T-I-M-E."
