Ethical Issues in CASA Cases for Volunteers and Judges

At last month's National CASA Conference, **The Hon. Douglas F. Johnson**, Juvenile Court Judge in Douglas County, Nebraska and **Nancy Wilson**, Executive Director of CASA of Douglas County, presented a workshop titled "Ethical and Evidentiary Issues in Abuse and Neglect Cases for CASA Volunteers and Judges." The workshop included a review of attitudes and values incorporated in the National CASA training manual, and discussed specific case studies in which ethical concerns had arisen.

CASA Program Directors' Manual Being Developed

"I need something that says *Read Me First*," said Bill Lamb, director of the new Ontario County CASA Program, housed within Catholic Charities of the Finger Lakes. Directors are given a variety of resources for reference: National CASA's *Achieving Our Mission*, training manual and facilitator's manual, and all the materials on CASANET; the State Association's *VOICE* and Affiliate Resources section on www.casanys.org; and the sections of the UCS CASA Program Manual distributed last fall.

But Bill's plea has been echoed over the years as all of that great material can sometimes be overwhelming or confusing. Where do those manuals overlap, agree or disagree? What is the highest priority when starting out or training new staff? Where do New York State laws, rules or procedures alter recommendations in national materials? Where does one look for more information on various subjects?

To address those concerns, CASA: Advocates for Children of NYS and the UCS CASA Assistance Program are working together to develop a Read Me First Manual outlining critical issues such as compliance with court rules, national and state standards; financial management and contract procedures; data collection; court and child welfare procedures and timelines; diversity and child well-being. The Manual will provide links to other online resources and lists of print publications available to support individual topics. The Manual will also incorporate some of the work the State Association had begun several years ago on a Program Director's Manual, as well as revisions of chapters previously distributed of the UCS Program Manual.

Much thanks to **Robin Robinson, Grace Thompson, Bill Lamb, and Linda Burns** for their willingness to work on this project. Our hope is to have a draft for review by the directors at the September Program Directors' Meeting. Comments and questions are welcome.

Court Rules Primer to be Included in Monday Morning Memo

Part of our discussion around the new Program Directors' manual included an interest in periodically highlighting pieces of the NYS UCS Court Rules governing CASA, as well as the state and national standards that they reference, both in UCS and CASANYS publications and at program directors' meetings.

In this issue, we will highlight §43.1: Use of CASA Programs from the rules of the Chief Judge. This section of the rules states that a CASA program "may be appointed by Family Court in its discretion to perform tasks delineated in a written court order regarding children in or at risk of placement in a child protective or foster care proceeding."

This is a slightly narrower description of appropriate CASA case assignments than in the National CASA standards, which state that CASA programs accept cases involving "children who come into the court system as a result of abuse or neglect." Cases meeting the definition in court rules generally would already have the involvement of the local Department of Social Services.

CASA programs accepting other kinds of cases such as private custody, PINS, Juvenile Delinquency, or supervised visitation generally do so under an umbrella of a broader program, and call that by a different

name. The National CASA Training Curriculum does not cover those types of case assignments, which means that additional training should occur if CASA volunteers are assigned.

LGBTQ In-Service for CASA Volunteers Available

Rob Conlon, Statewide Program Manager for Children's Centers, and Darlene Ward presented a inservice on Lesbian, Gay, Bisexual, Transgender and Questioning (LGBTQ) youth for the Fulton/Montgomery CASA Program in June. The pilot training discussed general awareness of LGBTQ issues, the challenges LGBTQ youth face in foster care, and the experiences of biological and foster parents. Much thanks to Linda Burns, CASA Director, for coordinating the training and to the receptive CASA volunteers of Fulton/Montgomery County.

The training included statistics and case examples, methods of creating a safe space for LGBTQ youth, basic terms and definitions, and community supports. Evaluations were very positive: "This changed my way of thinking," wrote one participant.
