CASA Focus Group Provides Feedback to OCFS for Upcoming Federal Review


This month, representatives of the CASA network met with the NYS Office of Children and Family Services (OCFS) to provide feedback about the strengths and challenges of the child welfare system and permanency process for children. CASA was one of a number of groups with whom OCFS has met in anticipation of next year's federal review of the child protection system, the Child and Family Services Review (CFSR).

The CFSR measures states' compliance with Titles IV-B and IV-E of the Social Security Act and assesses performance on safety, permanency and well-being outcomes. The review, the second of its kind, is conducted by the Department of Health and Human Services' Administration for Children and Families (ACF). The review measures the permanency process as a whole, which includes not only the performance of OCFS but of community-based agencies and the courts as well.

The CASA focus group was asked to offer their perspective about why NYS OCFS is getting the measures it is getting, what influences those measures, and what successes and obstacles to reducing time to permanency occur, particularly in cases involving substance abuse or physical and mental health challenges.

Representing the CASA network were Jackie Boissonault, Children's Advocacy Services in Westchester County; Mary Rich, CASA, Dutchess County; Barbara Benedict, CASA, Onondaga County; Pamela O'Leary, NYC CASA; Robin Robinson, NYS CASA Association; and Darlene Ward, CASA Assistance Program, NYS Unified Court System. In addition, a number of local directors provided comments in writing. Representing OCFS were Claire Strohmeyer and Joanne Passero.

Strengths identified by the CASA group included: best practice courts; youth advocacy and Teen Courts; children's appearance in the courtroom; shortened timelines required by recent permanency laws; comprehensive permanency reports; one judge/one family; more extensive advocacy on education issues; DSS and court collaborations; changes in law guardian reimbursement; use of mediation; increase in adoption subsidies; and greater awareness of the impact of trauma on children.

Areas of continued improvement noted included: more focus on the essential nature of visitation; more training and resources devoted to Interstate Compact cases; more community resources available for children's mental health treatment; and continued expansion of awareness and resources for adolescents aging out of care and infants entering the system. Challenges of working with relatives as options for placement and adoption were noted, as was the need for continued focus on strengths-based approaches to birth parents. The need for more Family Court judges was noted.

The focus group discussed how CASA can be of help in meeting some of these challenges as OCFS moves forward with its Performance Improvement Plan. CASA volunteers can assist local Departments of Social Service in identifying resources for the family and finding creative solutions to needs as they arise. CASA, as a neutral entity, can help in cases where parents may be resistant to DSS involvement, and assist in monitoring compliance with court orders. CASA also facilitates a focus on the child, and can help create a current and comprehensive profile of children for the courts. Particularly in cases where the child has been placed in an institutional setting, CASA can provide a constant contact for the child throughout the life of the case.
