ADMINISTRATIVE ORDER SIXTH JUDICIAL DISTRICT

Pursuant to the authority vested in me as Administrative Judge for the Sixth Judicial District to adjust, modify and/or cancel, in consultation with the appropriate Deputy Chief Administrative Judge, the terms of court for the empaneling of grand jurors and the number of panels designed for such terms as set forth in the Sixth Judicial District Annual Order for Terms 1 through 6, I do hereby order that the terms of the county court for the empaneling of grand juries

Chemung County

in the Sixth Judicial District be modified as follows:

Term Four is added and shall commence on 3/29/21 and end on 4/25/21. The grand jury empaneled in Term Four shall continue through Term Five (4/26/21 to 5/23/21) until a new grand jury is empaneled in Term Six, which begins on 5/24/21. Hon. Ottavio Campanella shall preside. The previously scheduled Term Five empanelment is cancelled.

Delaware County

Term Four is added and shall commence on 3/29/21 and end on 4/25/21. The grand jury empaneled in Term Four shall continue through Term Five (4/26/21 to 5/23/21) until a new grand jury is empaneled in Term Six, which begins on 5/24/21. Hon. Richard D. Northrup, Jr. shall preside.

Madison County

Term Four is added and shall commence on 3/29/21 and end on 4/25/21. The grand jury

empaneled in Term Four shall continue through Term Five (4/26/21 to 5/23/21) and Term Six

(5/24/21 to 6/20/21) until a new grand jury is empaneled in Term Seven, which begins on 6/21/21.

Hon. Michael St. Leger shall preside. The previously scheduled Term Five empanelment is

cancelled.

Schuyler County

The grand jury empaneled in Term Three, which began on 3/1/21 and ends on 3/28/21 shall

continue through Term Four (3/29/21 to 4/25/21) and Term Five (4/26/21 to 5/23/21) until a new

grand jury is empaneled in Term Six, which begins on 5/24/21. Hon. Matthew Hayden shall

preside.

Tioga County

Term Four is added and shall commence on 3/29/21 and end on 4/25/21. The grand jury

empaneled in Term Four shall continue through Term Five (4/26/21 to 5/23/21) until a new grand

jury is empaneled in Term Six, which begins on 5/24/21. Hon. Gerald A. Keene shall preside.

Broome, Chenango, Cortland, Otsego & Tompkins Counties

Each of these counties will utilize the currently summonsed "stand-by" grand jurors to

empanel a grand jury for Term Four. Those Term Four grand juries shall continue until the next

regularly scheduled grand jury empanelment as outlined in the 6th Judicial District's 2021 Annual

Order.
