Despite difficult economic times for all, you, our certified providers, have continued to provide high quality parent education to over 18,000 parents since the launch of the program in July of 2005. We now have fifty-one providers at 100 different sites throughout New York State.

Web Links

For some time now we have been making an effort to have other organizations (mostly statewide agencies) put a link on their website to our website as a way to 'get the word out.' We have an extensive list we track. In addition, the Public Affairs Department of OCA has made some contacts for us which we have followed up on. It is an inexpensive way to get 'lasting' publicity for your programs, so you should consider reaching out to your local networks to see if they will put a link to your website as well.

OCA's Office of Public Affairs—School Outreach

The Office of Public Affairs obtained the support of Mrs. New York America and assisted us in establishing relationships with community organizations to secure articles and links on their newsletters which have generated increased awareness about the Program.

In February, Mrs. New York America 2008, KerryLynn Boettcher, visited Kids First, one of our certified programs in Albany County. She met with the PEAP Counsel and Director and curriculum presenters and learned about the structure, mission and objectives of the Parent-Ed program. Her visit was featured by the local newspapers *The Albany Times Union* (Circulation: 100,000) and the *Schenectady Gazette* (Circulation: 90,000). As a sixth grade teacher, Mrs. New York America is supporting the efforts of the Parent-Ed program facilitating introductions to organizations in the educational community that can help raise further awareness about the program among teachers and parents.

Leveraging the support of elementary school teacher Mrs. New York America to Parent-Ed, the following opportunities to raise awareness about the Program were secured:

- ✓ **The National Parent Teacher Association (PTA)** is the largest volunteer child advocacy association in the nation. The April/May issue of its magazine, *Our Children*, featured an extensive article about the Parent-Ed program reaching 330,000 subscribers nationwide (<http://pta.org/2880.htm>). The magazine is distributed to local PTA chapters throughout the US via online and print versions.
- ✓ **The New York State Parent Teacher Association (NYS PTA)** granted UCS "cooperating partner status" and a Parent-Ed link placement on the cooperating partners section of their statewide website: <http://www.nyspta.org/about/partners.cfm>. NYS PTA defines this as a partnership in which a member of NYS PTA Board of Managers maintains personal communication with decision makers of the partner organization. Currently the NYS PTA has a membership exceeding 357,000 in 16 statewide regional districts and more than 1600 statewide local units and councils.

- ✓ **The New York State PTA Education/Advocacy Committee** agreed to distribute Parent-Ed brochures at meetings and conferences.
- ✓ **The New York State Student Support Services Center** sent an e-mail notice to over 8,000 school educators, counselors and administrators across the State. Information about the Parent-Ed program was also added to the “What’s New” section of their website, www.nyssscenter.org, and to the Family Involvement and Supportive Learning Environment sections. A related article was included in their newsletter, *Making Connections....to Increase Student Achievement*.
- ✓ **The New York Association of School Psychologists** included a link on its website section of resources for teachers and parents.

Other Outreach to Schools

By going on to the website, <http://www.nysed.gov/admin/adminindex.html>, you can obtain contact information regarding some of the school districts in New York, which are arranged alphabetically. We have been working on obtaining the names and e-mails of the guidance counselors, school psychologists and school social workers to e-mail them to tell them about our Program. You can consider looking for the school districts in your area and doing an outreach. Since schools are often the first to know about a separation or divorce in a family, they can get information to the parents about your programs early on in the process, which is so necessary.

Presentations about Parent Education

We have made presentations and distributed our materials to many groups, including Bar Associations, Attorneys for the Child (Law Guardians), Judges, Collaborative Law groups and Non-Judicial personnel, etc.

Summer Law Student Interns

This summer, as is our usual fashion, we are mentoring Pace Law Students who are assisting us with outreach contacts and are doing research for a law review article in the field on stepparents and blended families, and the legal and psychological issues which arise in that context.
